Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its Revised IRR.
- 6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 7. Prospective Bidder must have completed a single contract similar to the project, equivalent to at least fifty percent (50%) of the ABC of the lot/s being bid.

For purposes of this project, similar contracts shall refer to contracts *involving repair*, *renovation and/or construction of buildings*.
