1. The Department of Environment and Natural Resources (DENR) intends to apply the sum of **One Million Six Hundred Ninety Eight Thousand Two Hundred Fifty Two Pesos (₱ 1,698,252.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Improvement of Six (6) Restrooms of the Main Building of the Department of Environment and Natural Resources Regional Office III (DENR-ROIII)**:

2. Bids received in excess of the ABC shall automatically be rejected at Bid opening. Late bids shall not be accepted.
3. DENR now invites Bids from eligible bidders for the Improvement of Six (6) Restrooms of the Main Building of the Department of Environment and Natural Resources Regional Office III (DENR-ROIII) (herein after referred to as WORKS).
4. Completion of Works are as follows:

5. Open competitive bidding procedures will be conducted using a non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, otherwise known as the "Government Procurement Reform Act". All particulars relative to this bidding including Eligibility Checking, Bid Security, Evaluation and Post-Qualification Procedures and Award of Contract shall be governed by R.A. 9184 and its Revised IRR.
6. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organization with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
7. Prospective Bidder must have completed a single contract similar to the project, equivalent to at least fifty percent (50%) of the ABC of the lot/s being bid.

For purposes of this project, similar contracts shall refer to contracts *involving repair, renovation and/or construction of buildings.*



8. The Invitation to Bid and Bidding Documents may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) website.
9. The complete set of Bidding Documents may be acquired by interested bidders upon payment of the corresponding fee as indicated above not later than the schedule of submission of bids. The Bidding Documents shall be received personally by the prospective Bidder or his duly authorized representative upon presentation of proper identification document.

For the Pre-Bid Conference, bidders are encouraged to send their authorized technical representatives or personnel who are familiar with the bid requirements and will prepare the documents for the bidder.
